### **Cancellation Dates**

Any and all cancellations are subject to a \$100 per person fee up until 120 days prior to departure.

Any and all cancellations received from 119 to 90 days prior to departure - \$ 595.00 per person cancellation fee.

Any and all cancellations received 89 to 65 days prior to departure - \$ 995.00 per person cancellation fee.

Any and all cancellations received 64 days or less to departure – **no refunds**.

Any name changes or incorrect information not immediately brought to the attention of the club will incur an additional \$100.00-\$450.00.

ATI/NSC agrees to indemnify and hold harmless attendees from all costs, claims, liabilities, fees, attorney fees, and obligations related to harm caused by ATI/NSC's negligence or intentional misconduct. Attendees agree to be expressly and solely responsible for any damage or injury caused or suffered by any individual, or any person associated, affiliated, or related to any attendee.
- C. Waiver. - **E. Force Majeure.** Either party may terminate or suspend its obligations under this agreement to the other party if such obligations are delayed, prevented, or rendered impractical by the occurrence of any of the events listed, including but not limited to: fire, flood, earthquake, hurricane, civil commotion, insurrection, act of God, strikes, riot, pandemic, government action, provided that the party which is unable to perform its obligations provides notice to the other party as promptly as possible following the onset of such events or circumstances. In the event that such force majeure affects the meeting, either party may cancel all outstanding portions of the meeting without incurring any charges ATI/NSC's will in good-faith attempt to retrieve deposits paid to vendors, but cannot guarantee any cash refunds or airline and resort/hotel credits. Good faith does not include the requirement that ATI/NSC bring lawsuits against said vendors in any jurisdiction. ATI/NSC does hereby agree to assign any rights or claims against said vendors to the attendees.
